# Guidelines for implementation of the BoDs decision of 23 September 2022 regarding suspension of the Ukrainian Boxing Federation

# 1. Symbolics and Equipment

- a. The team shall compete in any competitions under the name: **IBA Ukrainian Team**.
- b. No symbolics of the Ukrainian Boxing Federations are allowed during the competitions.
- c. No political massages shall be transmitted or demonstrated by any member of delegation belongs to the IBA Ukrainian Team during or relating the competitions.
- d. Ukrainian flag and anthems shall be allowed during the official ceremonies.
- e. IBA will be entitled to decide on design and provider of the equipment for the IBA Ukrainian Team.
- f. IBA Head Office will develop the official emblem of the IBA Ukrainian Team which shall be used at equipment during or relating the competitions.

## 2. Registration

a. IBA Sports Department shall be responsible for the registration (entering to the IBA Database) of the IBA Ukrainian Team delegation members for any competition.

# 3. NF Representatives

a. No NF Representatives from the Ukrainian Boxing Federation shall be allowed to the competition. Nonetheless, the IBA Head Office may invite individuals from Ukraine in a neutral status to visit the competition.

#### 4. Team Delegation

- a. The IBA Ukrainian Team may include 1 Team Manager, 1 Team Doctor, 1 Physiotherapist, 1 IBA Certified Team Cutman, boxers and coaches. The IBA Vice President Mr. Volodymyr Prodyvus shall propose candidates to join the IBA Ukrainian Team for every competition.
- b. IBA Sports Department shall be responsible to verify any candidate to the IBA Ukrainian Team and approve the final list of the delegation after close consultation with the IBA Vice President Mr. Prodyvus based on the available budget.
- c. IBA shall be entitled to exclude any member of the delegation following inappropriate conduct.

### 5. Choice of competition

a. IBA Sports Department after close consultation with the IBA Vice President Mr. Prodyvus, shall decide the respective competitions for participation of the IBA Ukrainian Team based on the available budget.

#### 6. Competition Officials





a. As per Rule 25.5.1 of the Technical and Competition Rules, once a Competition Official has been duly certified by IBA, he or she shall be deemed directly affiliated to IBA. Therefore, such Competition Official may be invited to the Competitions as per the Technical and Competition Rules regardless of suspension of the Ukrainian Boxing Federation.
