# AIBA TECHNICAL AND COMPETITION RULES

# **Transitional Provisions**

#### INTRODUCTION

On 13 December 2020, AIBA has adopted a new Constitution. This resulted in the adoption by the Board of Organisational Regulations on 22 January 2021, defining, amongst other the composition, organisation and roles of the committees established by the Board in accordance with article 29.1 (l) of the Constitution. Such committees will be appointed in a near future and will assist AIBA in revising and improving the Technical and Competition Rules. The Technical and Competition Rules contain numerous references to bodies and commissions that existed under the former AIBA Statutes. The purpose of these Transitional Provisions is to adapt the Technical and Competition Rules to the new Organisational Regulations for a transitory period that shall expire once new technical and competition rules have been adopted by AIBA.

## 1. INTERPRETATION

- 1.1 Capitalized terms used in these Transitional Provisions shall have the meaning ascribed to them in the Constitution, in the Organisational Regulations and/or in the Technical and Competitions Rules.
- 1.2 In case of discrepancies between the definitions contained in the Technical and Competitions Rules and the definitions contained in the Constitution and the Organisation Regulations, the latter shall prevail.
- 1.3 The following terms used in these Transitional Provisions only have the meanings ascribed to them in this article:
  - "Constitution" means the AIBA Constitution adopted on 13 December 2020 together with all subsequent amendments.
  - "Organisational Regulations" mean the AIBA Organisational Regulations adopted on 21 January 2021, together with all subsequent amendments.

"Technical and Competitions Rules" means the AIBA Technical and Competitions Rules, last amended on 24 October 2020.

"Transitional Provisions" means these Transitional Provisions to the Technical and Competition Rules.

#### 2. TRANSITIONAL PROVISIONS

- Any reference to the "AIBA Disciplinary Commission" in the Technical and Competitions Rules shall be deemed to be a reference to either the Disciplinary Committee or the Ethics Committee, as applicable. If, according to the Technical and Competitions Rules a matter has to be referred to the "AIBA Disciplinary Commission", the matter shall be referred to the Disciplinary Committee, which shall then decide whether the Ethics Committee or the Disciplinary Committee has jurisdiction to deal with the matter at hand.
- 2.2 Any reference to the "AIBA Medical Commission" in the Technical and Competitions Rules shall be deemed to be a reference to the Medical and Antidoping Committee. Before the new Medical and Antidoping Committee has been duly appointed and is fully functioning, any matter requiring its intervention shall be referred by the AIBA Head Office and/or the President, as applicable, to the Ethics Committee or its chair in order to resolve the matter.
- 2.3 Any reference to the "AIBA Technical & Rules Commission" or the "AIBA Technical & Rules Commission task force" in the Technical and Competitions Rules shall be deemed to be a reference to the Competitions Committee.
- 2.4 Any reference to the "AIBA R&J Commission" or the "AIBA R&J Commission task force" in the Technical and Competitions Rules shall be deemed to be a reference to the Refereeing and Judging Committee.
- 2.5 Any reference to the "AIBA HQ" in the Technical and Competitions Rules shall be deemed to be a reference to the AIBA Head Office.
- 2.6 Any issue relating to the interpretation or the implementation of the Technical and Competitions Rules, notably with respect to the appointment and supervision of Competition Officials shall be referred to the Competitions Committee, which shall either decide the matter or refer it to the Refereeing and Judging Committee if it is within its competence. Any such issue arising before the new Competitions

Committee and Refereeing and Judging Committee have been duly appointed and are fully functioning, shall be referred by the AIBA Head Office or the Ethics Committee or its chair in order to resolve the matter, which may also delegate such tasks to any persons or entity independent from the Board of Directors.

2.7 For as long as the chairpersons of the new Competitions Committee and Refereeing and Judging Committee have not been appointed, any appointment letter of Competition Officials shall be signed by the President, by the Chairperson of the Ethics Committee or by a member of the Board.

#### 3. AMENDMENT TO THE RULES

Article 20 of the AIBA Technical and Competition Rules is amended as follows:

#### **RULE 20. BOUT REVIEW**

- 20.1. Implementation of the Bout Review
- 20.1.1. The Bout Review Rule will be in effect from September 2019 at the following. Competitions:
- 20.1.1.1. AIBA-owned Elite-level Competitions.
- 20.1.1.2. AIBA-sanctioned Elite-level Competitions.

### 20.1.1.3. AIBA Youth World Boxing Championships

#### 4. FINAL PROVISIONS

- 4.1 In the event these Transitional Provisions are translated into a different language or languages, the English version shall prevail.
- 4.2 These Transitional Provisions have been adopted by the Board by mail vote. They come into force with effect on 21 January 2021.
