A former Junior National Flyweight Champion in Boxing himself, Dian has been an ardent follower of the sport and has been actively engaged in its administration for the past 15 years. He was elected as president of the Boxing Association of Sri Lanka (BASL) for 8 consecutive years where he was instrumental in introducing corporate thinking to the sport, while implementing a long-term strategic plan for the Association; which resulted in a boxer participating in the Beijing Olympics in 2008 after a lapse of 40 years. He has also served in the International Boxing Associations (AIBA) Women's Commission (2014 to date) and was the first Sri Lankan to be appointed to the



Commonwealth Advisory Board on Sport (CABOS). Dian is passionate about working regionally and globally with to develop the sport of boxing, and is determined to win a medal at the Olympic Games for Sri Lanka through Boxing. He also served as the Vice President of the National Olympic Committee of Sri Lanka from 2004-2016. He was instrumental in the country winning three medals at the 2018 Commonwealth Games held in Gold Coast; a victory after 68 years for Sri Lanka.
