

EXPLANATIONS OF VOTING IN ELECTIONS



General Rules

Chairperson

AFBC Constitution:

20.2 During each Election Congress Meeting, the Chairperson of the Ethics Committee shall preside over the conduct of all elections for positions on the Board held at such Election Congress Meeting.

20.3In the event that the Chairperson of the Ethics Committee is unavailable to preside over the conduct of any election referred to in article 20.2, then such other member of the Ethics Committee, who shall be chosen by the remaining members of the Ethics Committee for the purpose, shall preside over such election.

Mr. Malek Badri, member of the Ethics Committee was chosen by the remaining members of the Ethics Committee to preside over this Election Congress Meeting

Procedure

- Electronic voting system will be used
- All candidates for election to an office on the Board must be present for that election at the Congress during which the election occurs (Article 26.1 of AFBC Constitution) => the Chairperson will make sure that all candidates are present at this meeting



Election of the President

Presentation of the candidates

Each Candidate will be granted the opportunity to make a short oral presentation to the Congress

Voting process

Article 26.2 of AFBC Constitution:

- One ballot. Absolute majority is required (not lass than half plus one of all of the National Federations in attendance at the Congress meeting)
- the candidate receiving the least number of votes in each successive ballot being eliminated from the next ballot
- In case of a tie: Further ballot shall be ran.
- In case of a tie in that further ballot, the chairperson shall draw the name of the successful candidate



Candidates to the President position

There are four candidates for the Presidential position admitted as eligible by the Interim Nomination Unit:

- Ferhat Abdelnour FAZIL (ALG)
- Bertrand MENDOUGA (CAM)
- Moses MUHANGI (UGA)
- Eyassu Wossen BERHAUN (ETH)



Election of Directors

Pursuant to Article 24.1 (b) of the AFBC Constitution, <u>12 (twelve) Directors</u> shall be elected Election Congress Meeting.

9 (nine) eligible candidates were admitted for the Elections

In the situation when less then 1 candidate for each position of the Director, pursuant to Article 26.3 of the AFBC Constitution, the candidates shall be deemed to be unanimously elected by **acclamation** at the Congress meeting concerned



Candidates to the Board

There are three candidates for the Presidential position (in alphabetic order) admitted as eligible by the IBA Ethics Committee:

- Alpha Amadou BALDE (GUI)
- Anta GUEYE (SEN)
- Nabil HILMI (MAR)
- Eric NDAYISHIMIYE (BUR)
- Siyabulela Cecil NKWALO (RSA)
- Irene NTELAMO (BOT)
- Azamia OMO-AGEGE (NIG)
- Zoubida WISSAM (MAR)



Two Candidates from same NF

Article 24.2 of AFBC Constitution:

Each Director serving on the Board shall be from a different National Federation, except for the Directors who are members of the Athletes' Committee.

The Elections will be conducted only between the candidates from the same National Association (Morocco): Zoubida WISSAM and Nabil HILMI

Voting process

- One ballot with two candidates (a candidate who receive the highest number of votes of Voting Delegates from all Eligible NF in attendance will be elected to the Board)
- In case of a tie: Seconf ballot shall be ran.
- In case of a tie in that further ballot, the chairperson shall draw the name of the successful candidate



Campaign Rules

- These elections and the campaign rules are established in the AFBC Regulations on Congress and Elections, approved by the Interim Board
- Before start of voting the Electoral Period will be closed, and any kind of campaigning is prohibited (Article 19.1 (2) of the AFBC Regulations on Congress and Elections) – this means that the candidates shall refrain from any campaigning (including sending messages) when the voting is open
- Each Candidates shall respect each other
- The Ethics Committee shall decide on each case whether a breach of these Regulations on Congress and Elections
- According to the recent Ethics Committee <u>decision</u>, Mr. Muhangi was given a warning for his first breach during the election campaign, however, he is still eligible to take part in the elections.
