I hereby declare that I fulfil all eligibility requirements listed under Article 5.1 of the IBA Organizational Regulations, as seen below:

Article 5.1. To be eligible to be appointed to as a member of a committee, a candidate must:

- a) never have been convicted of a serious criminal offence punishable by a term of imprisonment;
- b) not be the subject of a current or pending prosecution for the commission of a serious criminal offence punishable by a term of imprisonment;
- c) never have been sanctioned for a breach of (except for minor breaches, such as a breach of the Rules of the Games or a breach occurring with no fault or with light negligence):
 - i. the Constitution;
 - ii. the Regulations;
 - iii. the IOC's Code of Ethics;
 - iv. anti-doping regulations adopted pursuant to the World Anti-Doping Association (code) or any of its national derivatives;
- d) not to be bankrupt or otherwise insolvent under the law of the candidates place of domicile;
- e) not to be the subject of any current order made under the law of the candidates place of domicile declaring that person to be insane or of unsound mind, and;
- f) save without the expressed approval of the Board of Directors, a candidate cannot hold any position in any international boxing organization other than IBA or an IBA Continental Confederation.

I further confirm that:

I am not an active Referee and Judge (R&J), an active boxer or an active coach
I am not a former Competition Official having served on the occasion of an IBA Competition where judging has been subject to various controversies
I am not a member of an Organizing Committee of any IBA Competition or play an active role within an organizational capacity of an IBA Competition
