I hereby declare that I fulfil all eligibility requirements listed under Article 5.1 of the IBA Organizational Regulations, as seen below:

Article 5.1. To be eligible to be appointed to as a member of a committee, a candidate must:

- a) never have been convicted of a serious criminal offence punishable by a term of imprisonment;
- b) not be the subject of a current or pending prosecution for the commission of a serious criminal offence punishable by a term of imprisonment;
- c) never have been sanctioned for a breach of (except for minor breaches, such as a breach of the Rules of the Games or a breach occurring with no fault or with light negligence):
 - i. the Constitution;
 - ii. the Regulations;
 - iii. the IOC's Code of Ethics;
 - iv. anti-doping regulations adopted pursuant to the World Anti-Doping Association (code) or any of its national derivatives;
- d) not to be bankrupt or otherwise insolvent under the law of the candidates place of domicile;
- e) not to be the subject of any current order made under the law of the candidates place of domicile declaring that person to be insane or of unsound mind, and;
- f) save without the expressed approval of the Board of Directors, a candidate cannot hold any position in any international boxing organization other than IBA or an IBA Continental Confederation.

With reference to Article 5.5 of the IBA Organizational Regulations and the IBA Code of Ethics and Conduct (Conflicts of interest, articles 10-3), I declare that:

- I do not have and do not anticipate having any conflict of interests (actual, apparent or potential), except as disclosed below (or as an enclosure to this document)
- I agree to make immediate disclosure of any additional (actual, apparent or potential) conflicts of interest that may arise subsequent to the preparation of this declaration, by way of a separate declaration
