

3. COMPETITION

A. FORMAT

The Championships will be organized based on the latest IBA Technical and Competition Rules that can be found at the following <u>link</u>. In accordance with the rules, the following thirteen (13) Elite Men's weight categories:

•THIRTEEN (13) WEIGHT CATEGORIES WILL BE CONTESTED:

- All seeding will be applied based on current IBA Rankings. The seeding will be finalized based on the entries received at the official closure of registrations on **November 7**, **2025**.
- The Bout Review Rule will be applied throughout the full duration of the competition.
- Ten (10) oz gloves will be used for the Minimumweight category (46-48kg) to the Welterweight category (67kg). Twelve (12) oz gloves will be used from the Light Middleweight category (71kg) to Super Heavyweight category (92+kg).
- Professional hand wraps will be used as per IBA Technical and Competition rules.
- The Official Draw will be conducted by Sport Data through an electronic draw.
- Two rings will be used until the semifinals.
- Medals will be distributed to the first 4 boxers of each weight category (1 Gold, 1 Silver, 2 Bronze).
- The Event will be officiated by IBA International Technical Officials and IBA 3-Star certified Referees and Judges, all appointed by IBA.



B. PRIZE MONEY

IBA will award prize money in each weight category (subject to a number of key factors) and as follows:

Medal	Prize Money
Gold	USD 300.000
Silver	USD 150.000
Bronze	USD 75.000
Bronze	USD 75.000
5 th Place	USD 10.000

The IBA Men's World Championships in Dubai 2025 will offer USD 8.32 million in prize money, distributed across 13 weight categories to gold, silver, bronze medalists, as well as 5th place finishers.

Additionally, the prize money will be divided among the boxer, the coach, and the National Federation as follows: 50% to the athlete, 25% to the coach and 25% to the National Federation. In the case of an individual athlete, the 25% share due to the National Federation will be retained by the IBA and allocated to the special solidarity fund supporting athletes in developing countries. 25% will also be retained by IBA for those countries who receive special assistance regarding the Financial Support Program (FSP), in particular those who have been in full receipt of funding.

To be eligible for prize money, an athlete must win at least one bout. Prize money will not be awarded if only one athlete competes in a weight category.

For clarification:

- Medalists winning by walkover (WO) will receive prize money.
- Medalists without a bout or no wins will not receive prize money.
- Each boxer shall provide to the IBA, during the Sport Entries Check, the Prize Money Application Form (as per Annex B), duly filled in electronically, printed, and signed in original.

C. SPORT ENTRIES CHECK

The Sport Entries Check will take place over the period November 30th and December 1st, 2025 upon Teams arrival. Please ensure your timely arrival to arrive Dubai, United Arab Emirates prior to November 30th, 2025.

Each team delegation can appoint a maximum of two persons to attend the Sport Entries Check. The IBA recommends that each team send the respective Team Manager, Team Doctor, and/or Head Coach.



Each Team Delegation's representatives will have a 10-minute appointment with IBA Officials to confirm the entry list of their delegation, the correct spelling of boxers' names, the weight category, the uniforms, national flag and anthem and to present the official documents listed below to IBA.

Your representative(s) must present:

- 1. Entry list of the delegation.
- 2. Passports of each boxer.
- 3. Record Books of each boxer.
- 4. Examples of uniforms.
- 5. Results of Hepatitis B, Hepatitis C and HIV tests, not older than 6 months (boxers).
- 6. IBA General Participation Form signed by all team members.
- 7. Fit to Box form.
- 8. IBA Men's World Championships Code of Conduct signed by all team members.
- 9. IBA Medical certificates issued within the last 3 months for each boxer.
- 10. Anti-doping consent forms signed by each of the boxers.
- 11. Video consent form signed by team manager/head coach.
- 12. Prize Money Application Form (as per Annex B).

Important: Your representative's presence at the scheduled appointment is required. Failure to attend will result in disqualification of the entire team. Please bring all required medical documentation (Medical Certificate, HIV, Hepatitis B & C results).

5. REGISTRATIONS

A. PARTICIPATING BOXERS

Age eligibility: Boxers born from January 1, 1985 to December 31, 2006 will be eligible.

Introduction

The International Boxing Association (IBA) is dedicated to fostering inclusivity and upholding the highest standards of excellence in the sport. In pursuit of these values, the IBA ensures that all eligible athletes, whether amateur or professional, are provided with the opportunity to compete at the Men's Elite World Championships 2025. Although the Championships are classified as open, participation is regulated by well-defined eligibility criteria and selection principles.

Eligibility Criteria

To be considered for participation, boxers must represent IBA-affiliated National Federations and be officially entered through their respective Federations, in adherence to the IBA Technical and Competition rules, as well as the regulations outlined in the Championship Handbook. Each registered National Federation is cordially invited to enter up to one (1) boxer in each weight category. All registrations need to be done through the IBA database (https://www.iba-database.org/nf).

In circumstances where a Federation is unable to register its athletes, individuals may submit applications for consideration under specific categories described in Annex A. [].

- All athletes must be open class boxers, either amateur or professional.
- Each athlete must have completed a minimum of 20 verified bouts, with documentation maintained in an official record book (IBA, National Federation, or equivalent).
- Applications will be evaluated based on sporting merit, integrity, and the availability of
 places within each weight category. It is important to note that submission of an application
 does not guarantee acceptance.

Selection Process

The IBA *ad hoc* Selection Committee is responsible for evaluating all applications to ensure a process that is fair, transparent, and competitive. The Committee comprises senior executives, including the Secretary General & CEO, Sports Director, Representative of IBA Pro, International Relations Director, and Legal Counsel.

Registration Procedure

All applications and supporting documents are to be submitted to the designated email address: mwch2025@iba.sport. Final decisions regarding athlete participation will be communicated by 15 November 2025.



Summary

The IBA employs an inclusive yet selective approach to the Men's Elite World Championships 2025. While national nominations constitute the standard pathway to participation, individual applications, whether from amateur or professional athletes, may be considered in exceptional situations. Ultimately, final selections are determined by verified records, individual achievements, and the quota availability of slots in each weight category. B. TEAM OFFICIALS

Each team delegation or individual boxer can have the following number of team officials:

- 1 Team Manager
- 1 Team Doctor
- 1 Physiotherapist
- 1 IBA Certified Team Cut Technician
- Number of coaches according to the table below:

1 – 3 Boxers: Up to 4 Coaches

4 - 7 Boxers: Up to 5 Coaches

8 – 10 Boxers: Up to 6 Coaches

11 – 13 Boxers: Up to 8 Coaches

C. COACHES

Each Boxer will be entitled to be accompanied to the ring by up to three (3) coaches. However, only two (2) Coaches may mount the apron of the ring and only one (1) may enter the ring.

- All boxers must be accompanied by at least one IBA certified coach (1, 2 or 3-Star) at ringside during the bouts.
- All Coaches allowed to work in the Field of Play (FOP) must be IBA certified (1 to 3-Star).
- One of the 3 coaches can be replaced by an IBA Certified Team Cut Technician.

If your team does not have any IBA certified coach (1,2 or 3-star), please inform the IBA sport Department at mwch2025@iba.sport during the registration period, so arrangements can be made promptly.



D. EXTRA OFFICIALS

Any individual attending the event, in addition to those outlined in point B, whom the National Federation (NF) would like to send to work with the team, will be registered as an Extra Official.

Extra Officials who do not have a direct role in the team's preparation for the competition will not receive accreditation. Decisions regarding these cases will be made by IBA on a case-by-case basis; the final decision in this regard remains with the IBA Secretary General & CEO

Each National Federation can register up to 6 additional individuals in the following two categories:

All registrations for Extra Officials must be submitted through the IBA database in the dedicated section for the event.

Important: If you plan to bring more than 6 additional individuals, please note that accreditations will not be provided.



A. FOR TEAM DELEGATION MEMBERS

All Team Delegation members registered for the event through the IBA Database by the deadline will receive their accreditations on-site after the accommodation payment is approved by the Organizing Committee. Accreditations will only be issued upon presentation of a passport and after the accommodation cost has been paid.

11. TECHNICAL VIDEO RECORDING

Each National Federation will be allowed to record the bouts of their boxers with up to one camera per ring. Two specific locations in the stands will be reserved for these technical areas. Recordings are for technical purposes only and are not permitted for public broadcasting, including social media. Access to the two technical video recording areas will require the signature of a disclaimer, which you will find attached at the end of this Handbook. The team manager of each National Federation must bring the signed copy to the Sport Entries Check.

12. IMAGE RIGHTS

IBA has appointed several official photographers to promote the image of boxers during the World Championships. By participating in the Championships, each boxer agrees to grant IBA the right to use his or her image rights for promotional purposes, both during the event and in the future.

13. ANTI-DOPING CONTROL

Anti-doping controls will be conducted in accordance with the IBA Anti-Doping Rules and the World Anti-Doping Code. We would like to remind you that, according to WADA regulations since 2016, blood testing may be conducted during IBA competitions.

14. MEDICAL CARE



The Organizers will provide medical care and first aid during the entire Championships Period to any participant who sustains a sports injury incurred during the Championships.

Note on Outdoor Competition & Environmental Conditions

Please be advised that the **IBA World Boxing Championships will take place in an openair venue**. In December, **Dubai typically experiences daytime temperatures between 25–30 °C (77–86 °F)**, with mild evenings and relatively low humidity. Although the weather is generally pleasant, athletes may still experience mild heat stress, dehydration, or thermal fatigue when competing outdoors.

Competition sessions are scheduled to **begin in the afternoon and continue until late evening**, when temperatures gradually decrease. Teams should nevertheless take appropriate measures to help their athletes adapt to these environmental conditions.

We recommend the following precautions:

- Begin acclimatization training prior to arrival, including gradual exposure to heat and sunlight
- Monitor hydration closely and provide electrolyte-based fluids throughout the day
- Utilize shaded or ventilated warm-up areas and cooling devices (fans, ice packs, cooling towels)
- Encourage the use of breathable clothing and sun protection (caps, sunscreen)
- Observe athletes for any signs of heat-related discomfort (dizziness, cramps, fatigue)
- Adjust warm-up and pacing strategies during early competition days
- Inform the IBA medical team in advance of any athlete with heat sensitivity or pre-existing conditions

The **Organizing Committee** will implement all necessary **medical and sanitary safety measures**, including on-site medical supervision, hydration and cooling points, and established emergency procedures, to ensure athlete health and safety throughout the event.

15. INSURANCE

All participants are encouraged to obtain their own travel and medical insurance, as the LOC will provide liability insurance only at the Competition Venue for all participants.



16. AWARDS

Several awards, including the Best Boxer trophy of the IBA Men's World Boxing Championships Dubai 2025, will be presented after the last finals ceremony.

18. ZERO TOLERANCE POLICY

At the IBA Men's Elite World Championships, we uphold a strict zero tolerance policy towards discrimination, harassment, and unsportsmanlike conduct. Respect for all participants, officials, and supporters is the cornerstone of our message, ensuring a safe and inclusive environment where every individual is valued. We are committed to fostering a culture of fairness and dignity, reminding everyone involved that mutual respect is not just expected, but essential for the spirit and integrity of the competition.



ANNEX A – ELIGIBILITY CRITERIA FOR MWCH DUBAI 2025

1. GENERAL PRINCIPLES

The International Boxing Association (IBA) ensures that all athletes are given the opportunity to participate in the IBA Men's World Championships Dubai 2025, under clear, transparent, and inclusive eligibility criteria. Participation is open to both amateur and professional boxers, subject to compliance with IBA regulations and the procedures described below.

This Principles have been developed by the IBA Head Office in accordance with Rule 4 IBA Technical & Competition Rules.

All athletes must:

- Be duly registered in the IBA database or authorised through one of the special IBA categories listed below;
- Hold a valid passport;
- Present a valid medical certificate and insurance;
- Have completed at least 20 verified bouts (amateur or professional), recorded in an official record book (IBA, National Federation, or recognized professional body);
- Have no active disciplinary or anti-doping sanctions.

3. REGISTRATION PROCEDURES

All registration requests outside of the National Federation system must be sent to:

Each application must include:

- 1. Copy of valid passport;
- 2. Medical certificate and proof of insurance;
- 3. Copy of the IBA Record Book, or a sporting CV with competition results;
- 4. Participation request letter signed by the boxer

4. SELECTION PROCESS

The IBA *ad hoc* Selection Committee — composed of the Secretary General & CEO, Sports Director, representative of IBA Pro, International Relations Director, and Legal Counsel — reviews and validates all entries to ensure fairness and quality.

Selection is based on:

- Verified competition records and number of bouts;
- Performance in international or national tournaments;
- Sporting integrity and conduct;
- Availability of places within each weight category.

In case multiple applications are received from athletes of the same country in the same weight category, priority will be given according to:

- 1. IBA competition record and achievements;
- 2. Ranking or results from national/international events;
- 3. Date and completeness of the application.

Any decision about selection and admission of the athletes for participation at the IBA Men's World Championships Dubai 2025 shall be final and shall not be subject of any appeal.



5. DECISION TIMELINE

The following Prize Money has been established by IBA for the Competition: $1^{st} - 300,000$ USD, $2^{nd} - 150,000$ USD, $3^{rd} - 75,000$ USD, $3^{rd} - 75,000$ USD, $5^{th} - 10,000$ USD.

By signing this Form, the Boxer confirms accuracy of the above-mentioned information, including bank details. In the instance that the Boxer is entitled to receive the Prize Money as a result of his participation in the subject Competition, he agrees that IBA will pay **50% of the Prize Money** via wire transfer within Ninety (90) days following the Final's day of the Competition to the bank account provided by the Boxer in this Form. The Boxer agrees that other **50% of the Prize Money** will be distributed as follows:

- (i) 25% of the Prize Money will be transferred to the National Federation of the Boxer;
- (ii) 25% of the Prize Money will be transferred to the Coach of the Boxer.

In the case of an individual athlete, the 25% share due to the National Federation will be retained by the IBA and allocated to the special solidarity fund supporting athletes in developing countries. 25% will also be retained by IBA for those countries who receive special assistance regarding the Financial Support Program (FSP), in particular those who have been in full receipt of funding.



In order to be entitled to receive the Prize Money, the Boxer must win at least one bout within the subject Competition and reach a placed position from 1st to 5th, otherwise, IBA is not obliged to pay the Prize Money to the Boxer. Despite of this, if the Boxer is ready and fit to box, and steps into the ring to compete, but the opponent fails to show up (for whichever reason), then the Boxer wins (in accordance with the IBA Technical and Competition Rules) by Walkover, and shall still be entitled to the Prize Money subject to the respective achieved place. Categorically, under no circumstances will Prize Money be distributed or paid if the Boxer violates the Anti-Doping Rules.

IBA will be responsible for commissions and respective charges of its banking process, whereas a beneficiary will be responsible for commissions and charges of his/ her own bank. Neither federal, state, or local income taxes nor payroll taxes of any kind or any social charges from any country shall be withheld or paid by IBA on behalf of the Boxer or any other beneficiary. The Boxer or other beneficiary shall be responsible for payment of all taxes for remuneration received from IBA, including federal, state and local income or self-employment tax and any other tax or fee as may be required by the beneficiary's country of residence.

Undistributed funds (for example, when the recipient refuses to accept the money or in the absence of the National Federation or Coach) will be used by the IBA for the development of boxing.

The Boxer agrees, that IBA will categorically not be responsible if the banking of IBA is not able to transfer the payment to a beneficiary's bank due to sanctions, restrictions etc. In this case a beneficiary shall find a solution as to how to receive that payment from IBA.

Being registered to the Competition, the Boxer agrees to comply with the IBA Constitution, Technical and Competition Rules, Disciplinary and Ethics Code, Anti-Doping Rules, and other regulations, rules and policies of IBA. The Boxer hereby expresses his acceptance for IBA to collect, to store and process of his/her data for the purpose of this Agreement, for the Competition and IBA database, subject to the compliance with data protection laws.

This Form submitted by the Boxer and accepted by IBA, as a force of the agreement. The validity, interpretation, construction and performance of this agreement shall be governed by Swiss law as well as the parties shall submit to the exclusive jurisdiction of the Swiss courts in respect of any dispute relating to the agreement.

I acknowledge that I am bound by, and confirm that I shall comply with, all of the provisions of the IBA Statutes, IBA Competition Rules, IBA Disciplinary Code, IBA Anti-Doping Rules (as amended from time to time), the World Anti-Doping Code (the "Code") and the International Standards issued by the World Anti-Doping Agency, as amended from time to time, and published on the respective websites.
- 2. I understand and agree to the possible creation of my profile in ADAMS, which is hosted by WADA on servers based in Canada, and/or any other authorized National Anti-Doping Organization's similar system for the sharing of information, and to the entry of my *Doping Control*, whereabouts, *Therapeutic Use Exemptions*, *Athlete Biological Passport*, and sanction-related data in such systems for the purposes of anti-doping and as described above. I understand that if I am found to have committed an anti-doping rule violation and receive a sanction as a result, that the respective sanctions, my name, sport, *Prohibited Substance* or *Method*, and/or tribunal decision, may be publicly disclosed by IBA and its member National Federations and/or National Anti-Doping Organizations in accordance with the Code. I understand that my information will be retained for the duration as indicated in the ISPPPI.
- 3. I acknowledge the authority of IBA and its member National Federations and/or National Anti-Doping Organizations under the IBA Anti-Doping Rules to enforce, to manage results under, and to impose sanctions in accordance with the IBA Anti-Doping Rules and the IBA Disciplinary Code.
- 4. I acknowledge and agree that any dispute arising out of a decision made pursuant to the IBA Anti-Doping Rules, after exhaustion of the process expressly provided for in the IBA Anti-Doping Rules, may be appealed exclusively as provided in Article 13 of the IBA Antidoping Rules to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport (CAS).
- 5. I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
- 6. I understand that:
- a. My data, such as my name, contact information, birthdate, gender, sport nationality, voluntary medical information, and information derived from my testing sample will be collected and used by IBA, its Delegated Third Parties and member National Federations and/or National Anti-Doping Organizations and WADA for anti-doping purposes;
- b. WADA-accredited laboratories will use the anti-doping administration and management system ("ADAMS") to process my laboratory test results for the sole purpose of anti-doping, but shall only have access to de-identified, key-coded data that will not disclose my identity;
- c. I may have certain rights in relation to my *Doping Control*-related data under applicable laws and under WADA's International Standard for the Protection of Privacy and Personal Information (ISPPPI), including rights to access, rectification, restriction, opposition and deletion, and remedies with respect to any unlawful processing of my data, and I may also have a right to lodge a complaint with a national regulator responsible for data protection in my country;
- d. If I object to the processing of my *Doping Control*-related data or withdraw my consent, it still may be necessary for IBA, its Delegated Third Parties and member National Federations and/or National Anti-Doping Organizations and/or WADA to continue to process (including retain) certain parts of my *Doping Control*-related data to fulfill obligations and responsibilities arising under the Code, International Standards or national anti-doping laws notwithstanding my request; including for

Code of Conduct

In keeping with our continuous improvement and governance protocols, IBA hereby requests your fullest agreement in your capacity as a Boxing Competition Official, Team Official, Boxing Athlete or Delegate, to the following Code of Conduct, which will apply for the duration of this championship event, directly under the governing authority of IBA.

Integrity

- **1.0** I shall ensure that my conduct may not in any manner tarnish the reputation of the sport of boxing or IBA
- **1.1** I shall in all instances, respect all event regulations set by both IBA and the LOC for this championship event.
- **1.2** I shall not collude or collaborate with any party by violating any technical or hereby other rules of the sport or the IBA Disciplinary and Ethics Code.
- **1.3** I shall always conduct myself in a professional manner, respecting the organisation, the appointed Technical Delegate, all officials, and competitors to the event. This includes those supporting the LOC.
- **1.4** I shall not in any circumstances, directly or indirectly, solicit, accept, or offer any form of remuneration or commission, nor any concealed benefit, service or gift of any nature that could be considered as a bribe or undue influence.
- 1.5 I shall not bet on any part of the boxing competition, bouts, or anything that would conclude a decision of a contest; nor shall I share inside information at any time and in any circumstance

Reporting Obligations

2.0 I must immediately upon receipt, report any approaches or offers, such as those described under paragraphs 1.4/1.5, directly to the Technical Delegate or to the IBA appointed staff. Direct communication can also be made to the following email address integrity@iba.sport or by using the dedicated form on IBA official website.

Harassment

- 3.0 I shall not enter into any form of harassment or abuse, be it physical, professional, or sexual, and cause or instigate any physical or mental injuries outside of the competition. In this respect, I am aware of the IBA Anti- harassment Policy.
- **3.1** I shall not discriminate against anyone based on race, colour, religion, gender, age, national origin, disability, or sexual orientation.

Responsibilities of Boxing Competition Officials

- **4.0** Any information deemed confidential I may receive from IBA or may learn in the course of my duties as a Boxing Competition Official, must remain totally confidential and must not be disclosed.
- **4.1** I shall not become intimate or enter into any relationship with officials, boxers and/or coaches and seconds and/or other team delegation members. I shall not behave in any way which shall cast doubt on my impartiality as a Boxing Competition Official.
- **4.2** In the event that I have any type of relationship with officials, boxers and/or coaches and seconds and/or other team delegation members, I must immediately disclose this









- relationship(s) to IBA in writing at integrity@iba.sport I accept in advance that due to this relationship(s); I may not be allowed to further participate within the competition.
- **4.3** I shall fulfil my duties at the highest level. I shall never take biased decisions impacting the course of the outcome of the competition.
- 4.4 I shall not communicate with anyone about any event related issue within the competition venue and/or any other location of the full duration of the Championships and post event, especially to persons from my own country such as National Federation members, Board members, the media, the public. I shall not comment about any competition related issue on social media during or post event, nor shall I display any photographs during the Championships that may cause any kind of conflict or undue comment.
- **4.5** I shall be on time for all appointed competition duties assigned to me.
- **4.6** I shall be available to attend any Boxing Competition officials' meetings on or before the respective competition days.
- **4.7** I shall fulfil all duties assigned to me by the Technical Delegate with absolute due diligence.
- **4.8** I shall not use nor carry any electronic communication device, including but not limited to a mobile phone, a laptop, and a tablet computer, inside the competition venue. Exceptionally, the R&J Evaluators and Observers may use laptops to perform their official duties. Ringside Doctors are the exception based on their role requirements.
- **4.9** I shall always maintain a professional appearance when performing my duties as a Boxing Competition Official.
- 5.0 I shall not criticise or attempt to explain calls or decisions made by any Boxing Competition Official, including myself, unless requested to do so by the Technical Delegate.
- **5.1** I shall not be under the influence of alcohol or drugs, which will alter my judgement, while officiating or participating in any IBA competitions, including all related meetings, seminars, refresher training and weigh-in duties.
- **5.2** I shall not smoke in the competition venue, or any area not designated as such for smoking.

Interpretation and Sanctions

- **6.0** I agree to be bound by this Code of Conduct and the IBA Disciplinary and Ethics Code and the IBA Anti-Harassment Policy; I acknowledge that any infringement of this code may be referred to the IBA Ethics Committee and/or AIBA Disciplinary Committee and may lead to disciplinary measures and sanctions taken against me.
